A RESOLUTION OF THE LOUDON COUNTY COMMISSION ACCEPTING BATTLECREEK WAY, BLACKFOOT WAY, RED WOLF WAY AND A PORTION OF NORTH WILKERSON LANE LOCATED IN WARRIORS CHASE SUBDIVISION INTO THE PUBLIC ROADWAY SYSTEM, SAID ROAD LOCATED IN THE 5<sup>th</sup> LEGISLATIVE DISTRICT OF LOUDON COUNTY, TENNESSEE

WHEREAS, the Loudon County Commission has the authority under <u>Tennessee Code</u>
<u>Annotated</u> to accept the dedication of roads, to adopt policies and standards for the acceptance of new roads and to reopen previously closed county roads; and

WHEREAS, the Loudon County Regional Planning Commission has received a request from the property owners of Warriors Chase Subdivision to accept the following roads into the County Road system:

- 1) N. Wilkerson Lane (approximately .15 miles) and 50' of Right-of-Way; and
- 2) Battlecreek Way (approximately .16 miles) and 40' of Right-of-Way; and
- 3) Red Wolf Way (approximately .049 miles) and 40' of Right-of-Way; and
- 4) Blackfoot Way (approximately .05 miles) and 40' of Right-of-Way

WHEREAS, the Loudon County Regional Planning Commission approved the preliminary and final plat for the construction of the road and right of way dedication consistent with the minimum requirements of the subdivision regulations for Loudon County; and

WHEREAS, the Loudon County Road Superintendent has inspected the road and recommends acceptance of the road as a Loudon County Public Road;




