**Minutes:** Page moved to accept the minutes of the September 8, 2022 meeting. Hart seconded. Motion carried.

**Treasurer's Report:** Page reported a \$0 balance.

**Ocoee River Regional Library Report**: Report submitted. Director Schreck discussed the Standards Survey Analysis. MOEs are ready to be sent in. Training sessions will begin November 17.

Thomason called attention to the <u>Trustee Orientation</u> section in the handout. Discussion ensued. **By-Laws and Policy Development**: The Patron Behavior was discussed. Styer moved "that two additions be made to the policy: 'vaping' be added to line two; and the phrase, 'any behavior that is deemed to be of a threatening nature' be added to the last line." Seconded by Hart. Motion carried.

**Community Outreach**: With Waldmann absent, Thomason reported that the Storybook Trail is progressing, although at a slow rate. Susan Dorsey has agreed to be the project lead.

## Nominating Committee: no report

Personnel: Thomason will be meeting with Hall soon .

**Quarterly Data Reports**: Received from all five libraries. Dorsey guided trustees through the reports.

Guldan: Things are going well. She has been very busy.
